

Explains issues with garden. Explains who the volunteers are.

Explains why the garden is "weedy" - plants need to regerminate.

Events every 3rd Saturday. Open every Tuesday.

Dwaye Jackson Gardener: explains further the purpose of the garden and composting system.

Explains break ins to the garden and vandalism (about once a week). Wants funding. Linda: "second time that board has called us up. Board hasn't given the courtesy to call and say something."

[Has responsibility of garden and does homeless services. Isn't happy. Feels disrespected.]

Moises: responds- explains why the garden is called to the board. Explains that garden has only been here twice over 5 years. "If a board member has a concern, it goes on the agenda"

[Moises feels disrespected for Linda's disrespect. Doesn't feel welcome. Admonishes Linda for her aggressive attitude.]

Mr Dwayne: reads an email from an anthropologist at southwest college- wanted to take students to garden bc she liked it. College Students loved the garden. explains the weeds again and says that Moises misjudged weeds while driving by. Says Moises was rude on a phone call.

Moises: explains phone call; why garden was called onto agenda item.

Linda: explains their garden again. Public Cannot buy a plot. Is there for the entire community.

Moises: the people who reported the garden the first time aren't the same people who reported this time.

David (gardener): explains further a community garden vs private garden.
